## **EXECUTIVE SUMMARY**

Joshua French, Chief Executive Officer, Greater Sydney Parklands and Oriana Senese, Senior Manager Design and Strategy, Greater Sydney Parklands will attend the meeting of the Strategic Priorities Committee on 18 April 2023 to provide an update on two projects identified in the Western Sydney Parklands Southern Parklands Framework (2018).

#### RECOMMENDATION

That the Committee recommends:

That Council note the status report from the Greater Sydney Parklands representatives.

#### REPORT

Greater Sydney Parklands (GSP) became operational on 1 July 2020 and by legislation on 1 July 2022. It is a State Government Corporation that is autonomous but under the direction of the Minister. GSP manages five major parklands estates (6000 hectares) including the Western Sydney Parklands (comprising 5280 hectares). The Southern Parklands make up about 1500 hectares of that space, from the south of Elizabeth Drive in Cecil Hills down to Bringelly Road in Leppington.

The Western Sydney Parklands Plan of Management was adopted by the Minister for the Environment and Heritage on 17 December 2018. The Western Sydney Parklands Southern Parklands Framework was completed in 2018.

The Framework identifies several Parklands Land Uses:

- Unstructured Recreation and Events
- Active Recreation and Sport
- Nature
- Culture
- Tourism
- Community Facilities
- Urban Farming and Rural

A few inspirations for new infrastructure were included in the Framework from the Parklands' water paths and possibilities, and the lines and curves of the landscape. Two of those ideas are the Western Ridges Walk and the Mirror Dam Cycleway.

The Southern Parklands Framework provides the following information on these two projects.

#### The Western Ridges Walk (Gabrugal Yana)

This extensive walking trail promises to be an iconic new destination for locals and visitors alike. One of the unique features of the Southern Parklands is the continuous ridge that runs north to south along its full length – about 8.5 kms in all. Walkers along this ridge can enjoy an ever-changing landscape and some amazing views along the way, including a view from the Beauty Spot out to the Blue Mountains.

#### Mirror Dam Cycleway

Another memorable feature of the Parklands is a pair of twin dams, which sit on the same contour on each side of a central ridge. In a creative piece of landscape design, the projected cycleway cuts through these mirrored dams and two adjacent hills.

This unique gateway to the Southern Parklands takes cyclists from the M7 cycle path on a 15minute ride directly across the site. It finishes at the Liverpool Offtake Reservoir and can be accessed from the Wylde Mountain Bike Trail or Hinchinbrook Dam.
