### PRIORITY OF ACCESS GUIDELINES

As per the Start Strong Funding Guidelines set out by the Department of Education and Communities, NSW Community Preschools are required to give equal priority of access to:

- children who are at least 4 years old on or before the 31 July in that preschool year and not enrolled or registered at a school
- children who are at least 3 years old on or before 31 July and from low income and Aboriginal families
- children with English Language needs
- children with disabilities
- children who are at risk of significant harm (from a child protection perspective).

There is no order of priority assigned to the list of points above. The guidelines are intended to assist services with making enrolment decisions, in a way that seeks to allocate places to those in the greatest need. However, the particular community needs of the preschool will also be relevant.

- I understand that a waiting list application is not a guarantee for enrolment at Casula Preschool.
- I understand that that all enrolments are offered as per the Priority of Access Guidelines
