PAY FOR THE TIME YOU NEED

When using the meters motorists who are paying by cash are only required to insert \$2, \$1, 50c, 20c or 10c coins dependent on the

WHAT DOES 1P, 2P, 3P MEAN?

The restriction means motorists can only stay in the area for the stated time, either 1P, one hour of parking, 2P, two hours of parking or 3P, three hours of parking.

The purpose of the timed restriction is to encourage a quick turnover of vehicles. This has a positive outcome for motorists as there are spots available as well as a positive outcome for local businesses as customers can easily find parking.

Motorists may be fined if they exceed the time limit. Motorists who have exceeded the time limit and keep feeding the meter can still be fined.

Parking within the Liverpool City Centre

Liverpool City Centre is the third largest City Centre in the Sydney metropolitan area.

Liverpool has designated Taxi Zones and Taxi ranks throughout the City Centre

These Taxi Zones are located at the following streets and areas:

- George St, o/s Liverpool Westfield
- Northumberland St, o/s Liverpool Plaza
- Liverpool Railway Station
- Warwick Farm Railway Station
- Holsworthy Railway Station

Further information in relation to specific areas is contained within this pamphlet.

Places where taxis can stop

It is important that a driver does not stop in an area to which NO STOPPING or BUS ZONE signs apply regardless if dropping off/picking up passengers or goods. Taxi drivers **ARE NOT** exempt in these zones.

You **ARE** allowed to pick up and drop off in a LOADING ZONE, BUS LANE and NO PARKING areas. However you must leave the area as soon as possible after picking up or dropping off.

BIGGE STREET MEDICAL CENTRES There are available drop off points in Bigge Street and behind the centres in Warren Serviceway.

MACQUARIE STREET There is a NO PARKING zone adjacent to the pedestrian crossing. You may also stop in the LOADING ZONE and NO PARKING areas in the Georges Serviceway and Northumberland Serviceway—both access to Macquarie Street.

LIVERPOOL HOSPITAL There are drop off areas within the main entry off Elizabeth Street, as well as a NO PARKING zone in Campbell Street and Goulburn Street.

LIVERPOOL RSL CLUB You may pick up/drop off in the NO PARKING areas located in front of the club and opposite the club on George Street.

CENTRELINK

You may pick up/drop off within Northumberland car park, as well as in the NO PARKING or LOADING ZONE areas in Northumberland Serviceway.

Common offences

DISOBEY NO STOPPING SIGN

The road rules clearly state: *A driver shall not stop in an area to which a no stopping sign applies.*

Drivers are not allowed to stop in a NO STOPPING zone.

DOUBLE PARK

The road rules clearly state: *It is an offence to **stop** between a vehicle parked at the side of the road and the centre of the road.*

This applies under all circumstances, even if another motorist looks like they're leaving, or you are dropping off or picking up a passenger.

STOP IN BUS ZONE

It is an offence to stop in a BUS ZONE, unless you are driving a public bus. No exceptions. Drivers cannot stop to pick up passengers or goods in this area.

STOP IN LOADING ZONE

A driver must not stop in a LOADING ZONE unless the driver is picking up or dropping off passengers or goods; is driving a station wagon or any other vehicle constructed principally for the conveyance of goods.

NO PARKING

The driver of a vehicle must not stop in an area to which a NO PARKING sign applies. However, drivers can pause briefing in NO PARKING area to pick up/drop off passengers or goods and does not leave their vehicle unattended.
