THE CAPITAL OF SOUTH **WESTERN SYDNEY**

Liverpool is recognised as the strategic commercial centre of South West Sydney in the NSW Government's Plan for Growing Sydney and as a collaboration area in the Greater Sydney Commission's Western City District Plan. Considerable employment growth is expected, which will consolidate its position as the administrative and service centre for the South West region.

The Western Sydney City Deal, signed by the State and Federal governments and eight Western Sydney councils, included the establishment of an Industry Attraction Office in the Liverpool CBD. The FederalState-Local Industry Attraction Office will attract jobs and industry to the aerotropolis set to grow around Western Sydney Airport, which is wholly within the Liverpool LGA. WSA Co, the company that will build and run the \$5.3 Billion Western Sydney Airport, is also located in the Liverpool CBD.

Family and Community Services will open its Scott Street premises in late-2018, while several other government departments are establishing a presence in Liverpool.

A proposed amendment to the Liverpool Local Environment Plan in the Liverpool CBD (known as amendment 52) will facilitate thousands of square metres of A-Grade office space.
