SPECIAL UPDATE CORONAVIRUS UPDATE (COVID-19)

Dear friends and colleagues,

The Federal Government JobKeeper payment announced this week is designed to retain long-term casual, part-time and full-time employees – even if they have already been stood down. We encourage you to apply for this payment for your employees so that as the economy recovers there will be continuity for your business and security for your staff.

The Federal Government has also put evictions on hold over the next six months for commercial and residential tenants who are unable to meet their commitments due to the coronavirus.

The most up-to-date information for business support is available from the Australian government website www.business.gov.au, or by phone on 13 28 46. You can also find this information on the NSW Small Business Commissioner's website or by phone on 13 77 88.

We have been hearing from some sole traders who are unclear on what support is available. We've included a table in this newsletter outlining some of the Federal Government support available for employees, businesses and sole traders. We can also supply more information and links if you need further assistance.

If you need to understand how employees and employers can work together during this crisis, visit the <u>Fair Work Ombudsman</u> webpage. Find out about workplace entitlements and obligations if you're affected by the outbreak of COVID-19, including information on stand downs from work, working arrangements impacted by school closures, and pay and sick leave entitlements.

The Department of Industry, Science, Energy and Resources is hosting a webinar featuring speakers from Austrade and Exportia – a specialist in exporting Australian technology to Europe. SUPPLY CHAIN SHORTAGES

ICN has established a <u>portal</u> as a forum for managing supply chain shortages due to COVID-19, including identifying gaps in the supply chain and how they can facilitate local businesses that can help fill gaps.

The NSW Government would like to hear from suppliers that have the capacity to provide critical supplies, raw materials or manufacturing capability to produce critical supplies during the COVID-19 crisis. Supplies range from toilet paper to hand sanitiser. An emergency supplies <u>portal</u> is now open for registrations.
